

House of Hope Ministries is a Non Profit Charitable 501c3 Corporation Ministry serving inmates of jail, prison and after-care in Kitsap, King, Pierce County and Washington State.

FORGIVEN = FREEDOM

Imagine, if you will, seeing one woman after another who come from scandalous and abusive backgrounds. Many have been raped in their child-hood being traumatized at an early age and they don't know what to do with what happened to them. They usually use heavy drugs...and usually to excess. They don't have any 'worth'. They have been defiled, abused and abandoned. They generally act out in rebellion and get into big trouble and end up in jail.

Our mission, as Volunteer Religious Coordinators for House of Hope inside Kitsap County Jail – is to bring them hope and to help them see themselves in a different light.

One of the biggest keys to talk with them is about Forgiveness. We let them know how much the Lord loves them and that the Word of God is a Love Letter to them...to help them kick off the dark stuff that surrounds them. We explain that one of the biggest things that keeps them in the dark is if they hold on to un-forgiveness towards someone – or cannot forgive themselves. We walk them through scripture to help them see themselves in a new light.

Our Lord Jesus talks about Forgiveness in Matthew 6:14-15 For if you forgive others for their sins, your heavenly Father will also forgive you. But if you do not forgive others, then your Father will not forgive your sins. (We pause and then say to them – 'wow, that's a pretty serious word from Jesus!')

After sharing that scripture with them, another scripture is often used to emphasize that word: Matthew 18:21-35 which is the parable of the master settling accounts with is servants and at the end of that parable, Jesus says: 'My heavenly Father will also do the same to you, if each of you does not forgive his brother from your heart (he'll turn you over to the torturers)."

This is a big thing for them to comprehend. So we spend time with them to help them understand that any UNFOR-GIVENESS is actually choosing 'to go against God!! Forgiveness is a choice. The best example, we tell them, is Jesus on the cross! He forgave us of all our sin. The BIG DEBT!! And He shows us the example of dying for all of the sins of all people, even the ones who perpetrated such a horrific crime. We let them know that they are not designed to carry un-forgiveness or hatred towards anyone...and that by forgiving them and releasing them from their heart and giving them to God, their own hearts will become free.

It is amazing to watch these brave, courageous women face these horrible memories and hand the judgment over to the One good Judge! We see miracles when this happens. Many times we have seen people who have been plagued with a 10 year heroin addiction become completely set free because they forgave and started walking in the Word. It is a blessing and a privilege to serve the many women at Kitsap County Jail. Our goal is to bring 'the Lord's peace' to their mind, body and spirit, and help set the captives free 'in their hearts'.
